

Madeleine Onclin, Head of Sector Nutrition European Commission's Directorate for International Co-operation and Development (DG DEVCO)

Madeleine Onclin is a veterinary surgeon by training; for 11 years she was directly engaged in the fight against animal disease in Belgium, before creating the non-profit organisation Vétérinaires Sans Frontières-Belgium (VSF- Belgium, within VSF-Europa network).

In 2009, she joined the European Commission, extending her development work in Africa and to Central America. She worked in several EU Delegations, including

3 years in Chad, 3 years in Guinea-Bissau and 2 years in Honduras. She worked on a range of programmes for rural development and food and nutrition security, including in fragile situations. Since 1 September 2017, she headed Nutrition Sector at the European Commission's directorate for International Co-operation and Development in Brussels. The Nutrition team's role is to implement the European Commission's Action Plan for Nutrition with all partners involved in the fight against malnutrition.

Abi is an independent freelance consultant with over 25 years of international experience. She has been working for the European Commission's Nutrition Advisory Service as the focal point for Asia since 2014.
